*** **NEW** *** AQHA Boxing classes – There is **NO CHARGE** for this class IF one of the NRCHA/SRCHA concurrent classes are entered. Otherwise, pay the fee listed. The only charge for this class will be the AQHA drug charge of \$5.00 per horse/per day. Must have current AQHA memberships for the boxing class. Do not have to be a SRCHA/NRCHA member if **ONLY** entering the AQHA classes.

BOTH RIDER AND OWNER MUST BE A MEMBER OF THE SRCHA and NRCHA for NRCHA classes.

ENTRY DEADLINE

Cutting – Deadline is April 1, 2010 must be post marked by this date to avoid late fee of \$50.00. Entries will be accepted, with the late fee, after the due date until **12:00 noon** on Friday. Cutting will not start before 1:00 p.m. on Friday.

Cow Horse – Deadline is April 1, 2010, must be post marked by this date to avoid late of \$25.00. The draw for the first 2 sets of classes of day (including the concurrent classes) will be done the night before the class is held, after 5:00 p.m. After the draw, entries will be accepted for those classes until 1 hour prior to the start of the show, they will be considered late and will go first in the draw order.
Example: For Saturday all the Non Pro Bridle & concurrent classes and the Non Pro Limited and concurrent class will be drawn on Friday night. Same for Sunday. All Classes for the rest the day will be drawn at 9:00 a.m. All entries after that will be considered late and will go first in the draw.
